## CONVERSION PROGRAM PROGRESS REPORT: Valley View School in MA By Rev. Minister Angela Smith of COPE (https://www.cope.church) Dated: 5/26/21

The HEAL Mission of COPE has received 3 complaints from individuals and families alleging excessive use/abuse of psychotropic drugs, drugging children, physical abuse, one survivor reported via e-mail in 2013 "It's been four years since I attended, and I'm still feeling shock waves. I flinch when people hug me because I can remember them squeezing me in stress holds until I couldn't breathe. Loud noises scare me, especially yelling. I have anxiety attacks. I was drugged to the point of catatonia, the staff psychologist advising that they used a highly untested sleeping medication as a daily sedative. As a result of an extended period of overuse, I have developed issues with some of my memory. Chunks of my childhood among other times are gone", sexual abuse, the same survivor from the 2013 e-mail also reported "I remember one kid who got ganged up on by a bunch of other kids, and had a coat hangar shoved up his rear. I was there when he filled out the police report, but so was the staff, watching over his shoulder. Like what happened to me, the matter was solved behind closed doors, but his parents did take him out. The reason I'm writing this, is because when I was there I dreamed of someone coming to save me. Sometimes it was my parents, or my favorite video game character, any body. If telling my story can save some of those kids from that hellhole, then so be it", staff beating students, and suicides at Valley View School. Some of these complaints are referenced online and others remain confidential and on file with the church. With the intention of providing an opportunity for closure, clarification, and potentially peace, on 5/18/21 Rev. Angela Smith invited Valley View School victims (families and survivors) as well as staff whistleblowers to provide a guest sermon. That invitation read thus:

"Dear Valley View School Survivors and Families,

Valley View School is on the HEAL Mission watch-list (of fraudulent and abusive programs) and enrolled in the COPE Conversion Program based on your reports to the HEAL Mission alleging fraud, abuse, and/or other violations. The HEAL Mission and COPE Conversion Program (for Conversion Programs) has updated our protocols to provide entities populating the watch-list and/or enrolled in the COPE Conversion Program three ways off the watch-list or out of the program. Death and/or closure remains one way after which they will be buried at <a href="http://www.beyondbusiness.net/youarenext.htm">http://www.beyondbusiness.net/youarenext.htm</a> with the others who didn't make it off the list or reform in time. Programs enrolled in the COPE Conversion Program/placed on the watch-list are also eligible for graduation if they meet the minimum Honesty In Marketing Standards described and/or provided via hypertext link at <a href="https://www.cope.church/standards.htm">https://www.cope.church/standards.htm</a>. The third option is merciful release. Merciful releases are determined by date of last directly reported to the HEAL Mission complaint (date of incident(s) of abuse), whether those incidents occurred prior to when by custom or law the requirement to retain such records has expired, and whether Sponsors (you) are

actively participating or maintaining interest in holding your program accountable.

The most recent complaint the mission has received occurred in 2009 (if you were abused later than that then you did not include the dates of your enrollment when you contacted the HEAL Mission) on Valley View School. The custom is to retain such records for 30 years in Massachusetts. So, the requirements for merciful release have not been met. This is an invitation for you to provide a guest sermon no later than Wednesday, May 26th, 2021 at 8pm Pacific if you wish to provide one rather than have a progress report posted at that time. Here's how to participate:

1. In the body of an e-mail message write out your complete sermon and include answers to the following questions:

Did you report fraud or other unlawful actions to the proper authorities? If not, why? If so, what happened with the reports? (So, 2 part question)

Why do you believe Valley View School should remain enrolled in the COPE Conversion Program?

2. Send that guest sermon to me at <a href="rev@cope.church">rev@cope.church</a> with your first and last name (full) and notify me if you wish for your contact information to be included or for all feedback to be handled by the mission and/or church. Your full first and last name will be shared along with your sermon as written and provided by you. It will be posted as a Guest Sermon at <a href="https://www.heal-online.org">https://www.heal-online.org</a>/ <a href="https://www.heal-online.org/valleyview.htm">https://www.heal-online.org/valleyview.htm</a>, and <a href="https://www.cope.church/sermons.htm">https://www.cope.church/sermons.htm</a>.

If no one provides a guest sermon and there are no new complaints received by the HEAL Mission by December 31st, 2039, Valley View School will receive a merciful release.

Now, there was a vote on whether Valley View School should remain on the watch-list initiated on April 1<sup>st</sup>, 2020 where all Sponsors of that program's placement in the COPE Conversion Program were invited to participate. The Sponsors unanimously voted against merciful release or the equivalent at that time. HEAL Mission and the COPE Conversion Program recognize participation in the vote in April as recent enough participation even if Sponsors prefer more time to consider, write, and/or provide any guest sermon. While

we understand this may be disappointing for Valley View School, it is the hope that this progress report helps explain the reasons for the continued enrollment/placement in the COPE Conversion Program. Additional or continued participation by Sponsors, including providing guest sermons or participating in future votes will impact whether or not the program qualifies for merciful release or remains enrolled. Lack of participation by Sponsors, where all other criteria for merciful release are met, will result in merciful release of the program.

Similar invitations will be going out to all survivor/victim/whistleblower e-mail lists regarding their respective programs placed on the watch-list. It may take some time to get through the entire list especially if enrollments pick up. But, we are working on it and everyone can submit Feedback at <a href="https://www.cope.church/feedback.htm">https://www.cope.church/feedback.htm</a> at any time regardless of position regarding program placement or enrollment.

To close, I remind everyone that there are remedies at law. Labor trafficking, rape, fraud (misleading marketing/false advertising), false imprisonment, kidnapping, battery, assault, and any crime or tort you could name are actionable at law. The HEAL Mission of COPE is prepared to assist all victims by providing reporting resources and information for the sake of justice and we appreciate all Sponsors who selflessly contribute content for the sake of informing the public to help those exercising due diligence avoid becoming a victim.
